SUBJECT: Notice of Preparation of an Environmental Impact Report (EIR) for the Downtown Indio Specific Plan

The City of Indio (City) intends to prepare a program-level Environmental Impact Report (program EIR) for the proposed Downtown Indio Specific Plan. In accordance with §15082 of the California Environmental Quality Act (CEQA) Guidelines, the City has prepared this Notice of Preparation to provide Responsible Agencies and other interested parties with information describing the proposed Downtown Specific Plan and to identify its potential environmental effects pursuant to State requirements. Project Location: The Downtown Indio Specific Plan area is located in the central portion of the City of Indio. The plan area is identified in the City's adopted General Plan as the Downtown Planning Sub-area. The Specific Plan area is located adjacent to the Riverside County facilities, single-family units, commercial areas, and civic uses. Regional access to the Downtown area is provided by Interstate 10 to the north, Highway 111 to the south, and Indio Boulevard (Historic Route 99) to the east.

Planning Boundaries: The Specific Plan area covers approximately 117 acres. The area is generally bounded by the Indio Transportation Center to the northeast, Marshall Street to the southeast, State Route 111 to the south, Deglet Noor Street to the northwest, alleyway north of Highway 111 to Miles Avenue between Oasis Street and King Street to the west, and Indio Boulevard to the north. Please see attached project map.

Project Description: The proposed Downtown Indio Specific Plan will describe the goals and policies, development standards, design guidelines, infrastructure improvements, and implementation strategies for the project area. The City's adopted General Plan describes the City's vision to reestablish the project area as a special place within the City and the Coachella Valley, with enhanced commercial opportunities, public spaces, a pedestrian environment, and a multimodal transportation interchange.

The proposed Downtown Indio Specific Plan would replace the 1997 Old Town Indio Specific Plan with a flexible plan that emphasizes a walkable and mixed-use environment that complements the City's old town characteristics while embracing newer development. The goal of the Downtown Indio Specific Plan



is to encourage and promote economic development and revitalization to enhance the City's attractiveness to the local and regional marketplace. The Downtown Indio Specific Plan is anticipated to remove regulatory obstacles to the reuse of existing structure and promote infill development of currently vacant or underutilized properties. The plan would also facilitate and encourage residential mixed-use development, commercial/retail areas, and transit-oriented development in proximity to the Indio Transportation Center.

Project Approvals: Approval of the Downtown Indio Specific Plan will require amendments to the Indio General Plan, Zoning Code, and Zoning Map. The Downtown Indio Specific Plan, proposed amendments, and their implementation constitute the "Project" for purposes of the California Environmental Quality Act (CEQA).

Probable Environmental Effects: In accordance with the California Environmental Quality Act (CEQA) guidelines Section 15063(a), the City of Indio determined that an EIR would be required for this project. The following subject areas will be addressed in the EIR:

Aesthetics, Air Quality, Biological Resources, Cultural Resources, Geology/Soils, Greenhouse Gas Emissions, Hydrology/Water Quality, Land Use and Planning, and Transportation Traffic.

Pursuant to CEQA Guidelines Section 15060(d), "If the lead agency can determine that an EIR will be clearly required for a project, the agency may skip further initial review of the project and begin work directly on the EIR process....in the absence of an initial study, the lead agency shall still focus the EIR on the significant effects of the project and indicate briefly its reasons for determining that other effects would not be significant or potentially significant." Additionally, as stated in CEQA Guidelines Section 15063, if a lead agency can determine that an EIR will clearly be required for the project, an Initial Study is not required. In accordance with the aforementioned CEQA Guidelines sections, the City has prepared this Notice of Preparation for the proposed project without an accompanying Initial Study. The City will instead substantiate the elimination of a number of topical areas in the EIR and analyze relevant topics in detail in their respective sections of the EIR.

Responses: The City of Indio requests interested parties provide written or verbal comments as to the scope and content of the environmental information to be included in the Draft EIR, in connection with the proposed Project. The 30-day NOP review period starts on March 18, 2015 and ends on April 17, 2015. Due to the time limits mandated by State law, please send your written response to the City of Indio at the address below at the earliest possible date but no later than April 17, 2015 at 5:00pm. An informational Notice of Preparation Scoping Session is scheduled on Thursday April 2, 2015 from 5:00 pm - 7:00pm at the following location:
