Updated Draft Variance Policy

Input from WRSAC helped staff alter policy

- Variance circumstances
 - Additional residents, additional landscape area, new construction, medical needs, in-home care facility, special circumstances (on a case-by-case basis)
- Somewhat more strict
 - Documentation required if request is high/unusual
 - Second adjustment in one year requires participation in Water Audit, Smart Controller Program, or Turf Removal

Updated Prop 218 Notice

- Includes rate information
- Articles developed
- Additional language on how individual water budgets are calculated
- Highlights website, budget estimator, and participating in the process
