

Washing Machine Rebate

Wash more with less

Efficient washing machines get the job done with less water. Purchase a new water efficient washer with a **water factor of six (6) or lower**. Eligible models qualify for a \$150 rebate; rebate is limited to one (1) over the lifetime of an account. IWA does not provide a list of eligible brands or products.

Toilet Rebate

Get a new one



New, low-flow models use less water with each flush. Purchase a new, low-flow toilet that uses **1.28 gallons or less per flush** and you can get **up to a \$150 rebate**; rebate is limited to two (2) toilets over the lifetime of an account. **The toilet replaced must use 1.6 gallons per flush or higher.** Commercial customers, apartments and hotels are handled on a case-by-case basis. Please call IWA for more information. Waterless urinals are also eligible. IWA does not provide a list of eligible brands or products.

Terms and Conditions

Eligibility: Properties must use water from Indio Water Authority (IWA). The applicant's water account(s) must be in good standing.

Applicant Responsibilities: IWA is not responsible for faulty equipment or installation, and does not represent the customer, retailer, or manufacturer of rebated merchandise in any dispute or in any other way.

Installation: Customer agrees to purchase and install toilet(s) and/or clothes washing machine at customer's expense.

Recycling Requirement: Customer agrees to deliver old, inefficient toilet(s) to Desert Recycling Center, or a professional recycle center of their choice, at the customer's expense and provide a recycling receipt. **Applications submitted without proof of recycling toilets will not be accepted or approved.**

IRS Form W-9: Complete and sign an Internal Revenue Service (IRS) Form W-9. Rebates may be considered taxable income. IWA will issue a rebate check after all program conditions are met.

Rebate Requirements

High-Efficiency Washers: Qualifying washers must have a water factor of 6 or lower. Limit one (1) washer rebate per customer account. **Please provide a picture of the old washer's label displaying the model number.**

High-Efficiency Toilets: Qualifying toilets must use **1.28 gallons per flush or less**. Residential customers can receive up to \$150 per toilet, up to two (2) toilets per customer account.

Recycling: Old toilets must be recycled at customer expense; Desert Recycling (Thousand Palms) provides this service for a fee. **Recycling is mandatory.**



Valid Receipt from Purchase: Customers must provide IWA with the itemized dated sales purchase receipt(s) for any product included in this program. Purchase must be within 180 days of rebate application date. Rebates will not exceed the purchase amount of the rebate product.

Availability: Rebates will be processed on a first come-first served basis based on fund availability, issued as a check to the applicant.

STEPS

- Purchase your eligible low-flow toilets or washer; take a picture of existing clothes washer before removal to show make/model
- Email, drop off, or mail the application, W-9, purchase & recycling receipts (mandatory for toilets)
- You can expect your check in 6-8 weeks after final approval
